6. Business Arising from Minutes – Jun 18, 2019

6.1 Status of OMCC funding recommendation

The PATC recommended that these funds (\$75,000 OMCC) be used to pave the Steve Bauer Trail between Port Robinson Road and Quaker Road. Council has agreed and this item has been deferred to 2020.

6.2 Review of AT Master Plan subcommittee update

Brian provided a handout and discussed the review of the master plan including four priority projects to put forward over the next few years and 12 outcomes for the PATC to consider. The sub-group will meet weekly to review the ATMP outcomes.

6.3 Lathrop property access update

A recent news article alluded to planned work on the pond, located on the property, designed to lower the water temperature in an effort to protect Twelve Mile creek. The Niagara Peninsular Conservation Authority is planning this work in 2021. This work may provide an opportunity to ensure and improve public access to the Lathrop property.

Action: Town of Pelham staff are asked to provide more information about the NPCA plans and to acknowledge the PATC's interest in ensuring there is public access to the property.

6.4 Joint meeting - Welland & Thorold AT committees, October 29

The meeting will be held at the Thorold City Hall at 6:00 p.m. We will discuss potential sources of funding for Thorold/Fonthill/Welland Spur and potential improvements on Port Robinson Road from Fonthill to the GNCR.

Action: Town of Pelham staff are asked to provide a large map of Pelham for the meeting.

6.5 Downtown revitalization grant follow-up

Staff are looking at locations to place new bike lockers.

6.6 Mapping signed loop rides

Brian outlined locations for potential routes. He will continue to scope out proposal for proposed routes as part of our priorities. Committee members also expressed an interest in the signage of walking routes along Pelham trails.

6.7 Niagara Cycling Clubs Alliance offer to assist with BFC

The feedback from Share the Road regarding Pelham's Bike Friendly Communities submission and silver designation has been shared with the NCCA. Dave Hunt, NCCA alternate director, will join our next meeting to discuss how the NCCA is proposing to assist in future submissions.
