

Acceptable Voter Identification:

The following chart outlines acceptable proof of identity and residence that you must bring to your voting place:

One piece of ID showing your Name and Qualifying Address (an original, or a certified or notarial copy, of a document listed below)

<input type="checkbox"/> Ontario Health Card (photo card)
<input type="checkbox"/> Ontario Photo Card
<input type="checkbox"/> Ontario motor vehicle permit (vehicle portion)
<input type="checkbox"/> Cancelled personalized cheque
<input type="checkbox"/> Mortgage statement, lease or rental agreement relating to property in Ontario
<input type="checkbox"/> Insurance policy or insurance statement
<input type="checkbox"/> Loan or financial agreement with a financial institution
<input type="checkbox"/> Document issued or certified by a court in Ontario
<input type="checkbox"/> An income tax assessment notice
<input type="checkbox"/> Child Benefit Tax statement
<input type="checkbox"/> Any other document from the Government of Canada, Ontario or a municipality in Ontario or from an agency of such a government
<input type="checkbox"/> Any document from a Band Council in Ontario established under the <i>Indian Act</i> (Canada)
<input type="checkbox"/> Statement of Employment Insurance Benefits Paid T4E
<input type="checkbox"/> Statement of Old Age Security T4A (OAS)
<input type="checkbox"/> Statement of Canada Pension Plan Benefits T4A (P)
<input type="checkbox"/> Canada Pension Plan Statement of Contributions
<input type="checkbox"/> Statement of Direct Deposit for Ontario Works
<input type="checkbox"/> Statement of Direct Deposit for Ontario Disability Support Program
<input type="checkbox"/> Workplace Safety and Insurance Board Statement of Benefits T5007
<input type="checkbox"/> Property tax assessment
<input type="checkbox"/> Credit card statement, bank account statement, or RRSP, RRIF, RHOSP or T5 statement
<input type="checkbox"/> CNIB Card or a card from another registered charitable organization that provides service to persons with disabilities
<input type="checkbox"/> Hospital card or record
<input type="checkbox"/> Document showing campus residence, issued by that post office or officials responsible for student residence at a post-secondary institution
<input type="checkbox"/> Document showing residence in a long-term care home under the <i>Long Term Care Homes Act, 2007</i> , issued by the Administrator for the home
<input type="checkbox"/> Utility bill for hydro, water, gas, telephone or cable TV or a bill from a public utilities commission
<input type="checkbox"/> Cheque stub, T4 statement or pay receipt issued by an employer
<input type="checkbox"/> Transcript or report card from a post-secondary school

Alternatively, a person may complete an application in the prescribed form, including a statutory declaration that they are the elector shown on the voters' list.
